## CAMBRIDGE UNIVERSITY AWARDS A CONTRACT TO BOUYGUES CONSTRUCTION'S BRITISH SUBSIDIARY FOR THE CONSTRUCTION OF ITS NEW EXAM BOARD HEADQUARTERS

Cambridge Assessment, which is responsible for the operation and management of Cambridge University's examination boards, has awarded Bouygues UK, the British subsidiary of Bouygues Construction, a contract worth €165 million (£120 million) to design and build its new international headquarters, to be called The Triangle.

**Simon Lebus, Group Chief Executive of Cambridge Assessment, said:** "After a long and thorough tendering process we are delighted to have appointed Bouygues UK and are very much looking forward to working with them. Bouygues UK is an award-winning company that is committed to exceptional construction and sustainable practices and has experience in both the public and private sector. I am confident that they are the right partners to help build our new global headquarters."

Cambridge also represents a new geographic area for us, where we see great potential for our business."

Cambridge Assessment is a not-for-profit organisation that designs and delivers assessments to over eight million learners in over 170 countries.

The organisation's new headquarters will be based on a brownfield site previously occupied by Cambridge University Press. The 2.5 hectare plot previously housed two warehouses and an office building, which have been demolished to make way for the construction of two new five-storey office blocks and a 39-metre tower. The buildings will be connected by a main courtyard.

Designed by Eric Parry Architects in conjunction with HLM Architects, the project was developed using the latest Building Information Modelling (BIM) technology and is expected to take around two years to deliver. With a strong focus on sustainability, it is expected to achieve an Energy Performance Rating of A and is targeting the same Display Energy Certificate (DEC) grade for office developments. Work has started on site, and handover is timetabled for September 2017.

Operating in the United Kingdom for around 20 years, the Group has progressively grown its businesses in the sectors of building (Bouygues UK), energy and services (Bouygues Energies & Services), civil works (Bouygues Travaux Publics) and property development (Bouygues Development). The Group is strongly positioned on the United Kingdom education sector, having built numerous schools and scientific facilities.
